

Re: International Chrysotile Association Attacks on Rotterdam Convention

Dear Rotterdam Convention Secretariat,

We are writing to you to express our extreme disquiet and concern over the attacks on the Rotterdam Convention (RC) and Chemical Review Committee (CRC) by the International Chrysotile Association (ICA) – the propaganda machine representing global asbestos stakeholders.¹

Our organizations represent civil society groups in Asia, Oceania, Latin America and Europe. Collectively, we speak for millions of trade unionists, asbestos victims, medical professionals, technical experts and concerned citizens. We have seen at previous RC Conferences of the Parties how a handful of countries, initially led by Canada and more latterly by Russia, have callously blocked the listing of chrysotile asbestos on Annex III of the RC despite overwhelming support by Parties to the Conference for chrysotile to be added to the Annex.

The ICA presence at the COP is a mystery to us. They are clearly a group with a vested commercial interest in preventing the RC from achieving its stated objectives:

"to promote shared responsibility and cooperative efforts among Parties in the international trade of certain hazardous chemicals in order to protect human health and the environment from potential harm; to contribute to the environmentally sound use of those hazardous chemicals, by facilitating information exchange about their characteristics, by providing for a national decisionmaking process on their import and export and by disseminating these decisions to Parties."²

As tobacco companies are now barred from meetings of the ILO and WHO we once again ask you why the ICA is allowed to participate as an Observer at the COP 2022 of the RC and is allowed to hold a side-event with the contemptable and provocative title: SDGs: The contribution of chrysotile asbestos.³ The use of a class 1 carcinogen to promote Sustainable Development Goals is a logical impossibility; the title of this proposed side event is, said British expert Rory O'Neill, both "disingenuous and damaging."⁴

Given the increased frequency and severity of climate-induced disasters, the state-of-the-art knowledge about the hazard posed by chrysotile asbestos,⁵ the UN Human Rights Council Resolution (2021) recognizing the right of human beings to live a life free from exposures to deadly toxins,⁶ plans by the ILO to make the right to healthy work a fundamental human right and other similar developments, the inclusion of the ICA side event on the official RC program is an outrage.

The proposed ICA side event does **not** make a positive contribution to the discussion at the COP. It is a propaganda tool to spread confusion and uncertainty amongst delegates in order to frustrate progress being made which would protect vulnerable populations from even more years of toxic exposures. Asbestos stakeholders are desperate to prevent importing countries being provided essential information to make informed decisions about whether chrysotile asbestos and products containing it can be safely used by their citizens. The right-to-know the human health and environmental risks posed by importing asbestos is not tantamount to a ban on asbestos but is most certainly a boon to decision-makers.

We therefore call on you to rescind the invitation for this side event and eradicate it from the program. Furthermore, we call on the Secretariat to take steps to bar the ICA and other proasbestos lobbying groups from attending convention meetings.

Due to the commencement of the 10^{th} Conference of the Parties to the Rotterdam Convention on June 6, 2022, we ask for a reply to this letter by June 5. Please reply to Laurie Kazan-Allen by email at: <u>lkaz@btconnect.com</u>

If we fail to receive a reply to this communication, we will upload it in its totality to the internet to raise awareness of the profit-driven and despicable attempts to undermine a multilateral treaty intended to protect global populations from exposures to deadly substances.
